Subject: Answers to Frequently Asked Questions for the Exam(s)

How long does the exam last? A timeframe of three (3) hours is allowed to take the exam. The average time for participants is between forty-five (45) minutes to one (1) hour.

Is the exam open book? No

Will I need a calculator? No

Will I need to bring pen or pencil? No, everything is provided

Can I have my cell phone with me? No. Absolutely no electronics are allowed in the exam room

How do I know the exact address of the exam location? As stated on the exam application, you will receive an email confirmation before the exam date with a check-in time and exact address for the exam.

Will I receive a reminder a few days before the exam? No. The email confirmation will be the only notification you will receive.

What if I arrive late for the exam time? You will have to reschedule for a later exam date.

What if my required documents don't arrive in time for the exam registration cutoff? You will not be confirmed for the exam.

How do I know my required documents have arrived? Send your documents with tracking for delivery verification.

Can I call the day my documents get delivered to verify they have been received? Processing each package takes time, and the office will not have a way to verify your specific documents have been received on date of delivery. Allow about a week processing time before calling to verify receipt. Be sure to add the email address of csstephens@ncowcicb.info is in your email contacts to assure your confirmation is received once the documents get processed and you are confirmed for the exam.

What do I need to study for the exam? The exam(s) are based on foundation knowledge that you will need to know as you progress through the industry.

The 2024 Exam Versions are based heavily on the 18E Rules that apply to systems permitted after 1/1/2024.

Applicants should be aware that systems permitted prior to 1/1/24 are based on 15A NCAC .1900 Rules.
